The Institute of Auditing (TIA-Pakistan) is registered and was established in 2022/2023 in Islamabad, the Federal Capital of Pakistan, under the laws of the Islamic Republic of Pakistan under Section 42 of the Companies Act 2017 with the Securities Exchange Commission of Pakistan (SECP) as a non-profit professional Institute/Body dedicated to the development and expansion of the practice of Internal Auditing, Risk Management, Governance, and its allied areas. The Institute of Auditing (TIA-Pakistan) is the first pioneer-recognized professional internal auditing Institute in Pakistan.

Minimum Entry Eligibility

Minimum eligibility required for admission in Internal Auditing Professional (IAP) Program is graduation from any discipline or any other recognition qualification equivalent to graduation.

Duration of IAP Program

The Internal Auditing Professional (IAP) Program may be completed in a period of three years (36 months).

Exemptions/Waivers

Individuals who possess prior academic qualifications, professional qualifications, and practical job experiences, such as B. Com, BBA, M. Com, MBA, CIA, CICA, CFE, CA / CMA / CS, CPA, PFA, IBP Members, or IFAC registered body's member may be eligible for exemptions or waivers from certain subjects in all stages of the Internal Auditing Professional (IAP) Program on a case to case basis.
